#### Subject : Visa restrictions related to COVID-19

This is in continuation of our communication No.1/Comm/Bol/2020-87 dated 16.03.2020 and no. 75/Health/2020-II-633 dt. 17.03.2020 on the subject mentioned above.

2. As per Government instructions, any passenger from any destination who have been to European Union. European Free Trade Association, Turkey. United Kingdom. Afghanistan, Philippines and Malaysia on or after February 15, 2020, have been prohibited from entering India, from any of the Land/Air/Seaport ICPs with effect from 1200 hrs GMT on March 18, 2020 at the port of first departure.

3. In view of the above no airline will take on board any passenger from any destination who has been to UK. European Union (27 countries), European Free Trade Association (4 countries), Turkey, United Kingdom, Afghanistan, Philippines and Malaysia on or after February 15, 2020 for onward journey to India.

4. The above instructions may be shared immediately with all concerned Airlines/ Shipping agents etc and all immigration officers/ ICPs under your jurisdiction for immediate implementation **REPEAT the above instructions may be conveyed to all concerned positively**.

## Subject : Visa and Travel restrictions related to COVID-19

In addition to the Visa and travel restrictions already in place issued vide BOI communication No.1/Comm/BoI/2020-87 dated March 18, 2020, the following travel restriction shall also come into effect for immediate implementation.

- i. All passengers coming from Afghanistan, Philippines and Malaysia are prohibited from entering India from any of the Land/Air/Seaport ICPs with immediate effect.
- ii. Airlines may be advised that no flight shall take off from these countries to India after 1500 hrs IST. The airlines shall enforce this restriction at the port of initial departure.
- ili. This instruction is a temporary measure and shall remain in force till March 31, 2020 and shall be reviewed subsequently.

2. The above advisory may be shared immediately with all concerned Airlines/ Shipping agents etc and all immigration officers/ ICPs under your jurisdiction for immediate implementation.

# Subject : Visa and Travel restrictions related to COVID-19

In addition to the Visa restrictions already in place issued vide BOI communication No.1/Comm/BoI/2020 dated March 13, 2020, the following travel restriction shall also come into effect from 1200 GMT on March 18, 2020:

 All passengers coming from European Union (Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden), European Free Trade Association (Iceland, Liechtenstein, Norway and Switzerland), Turkey and United Kingdom have been prohibited from entering India from any of the Land/Air/Seaport ICPs. This restriction shall come into effect from 1200 hrs GMT on March 18, 2020 at the port of first departure, and shall remain till March 31, 2020 and is a temporary measure.

2. The earlier visa restrictions issued vide our communication of even no. dated March 13, 2020, as mentioned below, shall also remain in force;

- i. All existing visas issued to nationals of any country except those issued to Diplomats, Official passport holders, those in UN / International organizations, those on Employment, Project visas and those who are operating aircrew of scheduled commercial airlines, and who had not yet entered India, stand suspended w.e.f. 1200 GMT on March 13, 2020 till April 15, 2020.
- ii. Visas of all foreign nationals already in India remain valid. They may contact the nearest FRRO/FRO through e-FRRO module for extension/conversion etc. of their visa or grant of any consular service.

- The validity of OCI card of foreigners presently in India shall remain.
- Visa free travel facility granted to OCI card holders who are not in India presently, has been kept in abeyance till April 15, 2020. This has come into effect from 1200 GMT on March 13, 2020 at the port of departure of any foreigner for onward journey to India.
- Any foreign national (including OCI cardholder) who intends to travel to India for compelling reasons may contact the nearest Indian Mission for fresh visa.
- vi. International traffic through land borders will be restricted to designated Immigration Checkposts that have been notified by MHA vide O.M. No.25022/12/2017-Imm dated March 14, 2020.

## Mandatory compliance of travel advisory issued by Ministry of Health and Family Welfare, Gol.

- i. Passengers travelling from / having visited Italy or Republic of Korea and desirous of entering India will need certificate of having tested negative from COVID-19 from the designated laboratories authorized by Health Authority of these countries. This is enforcement since 0000 hrs. of March 10, 2020 and is a temporary measure till cases of COVID-19 subside.
- ii. All incoming travellers, including Indian nationals, arriving from or having visited China, Italy, Iran, Republic of Korea, France, Spain and Germany after Feb. 15, 2020 shall be quarantined for a minimum period of 14 days. This will come into effect from 1200 GMT on March 13, 2020 at the port of departure.
- iii. All passengers coming from UAE, Qatar, Oman and Kuwait will be placed under compulsory quarantine for a minimum period of 14 days which shall come into effect from **1200 hrs GMT on March 18, 2020** at the port of first departure.
- iv. Incoming travellers including Indian nationals are advised to avoid non-essential travel and are informed that they can be quarantined for a minimum period of 14 days on their arrival in India.

Indian nationals are further strongly advised to refrain from travel to China, Italy, Iran, Republic of Korea, Japan, France, Spain & Germany.

vi. All incoming international passengers returning to India should self-monitor their health and follow required do's and don'ts as detailed by the Government.

vii. International traffic through land borders will be restricted to designated check posts with robust screening facilities. These have been notified separately by Ministry of Home Affairs.

- viii. All international passengers entering into India are required to furnish duly filled self-declaration form in duplicate (including personal particulars i.e. phone no. and address in India) (as annexed) to Health Officials and Immigration officials and undergo Universal Health Screening at the designated health counters at all Points of Entry.
