In the wake of several Corona infected people found to be linked with Tabligh Jamaat Hqrs., Nizamudin, New Delhi, communal tension is building up across the country. A number of communally provocative messages are also in circulation on the social media, which is generating negative sentiments towards the Muslim community.

Although as of now, there is no communal situation in Mizoram, the discussions on social media reveal that people do not want Muslim migrant workers, who went home to Assam, to return after the lockdown until the situation in the bordering districts of Cachar, Halakandi & Karimganj comes back to normal.

Therefore suitable measures need to be in place to prevent any kind of communal situation in Mizoram in future.
